## 2016-2017 Project Manager Report

If I were to think about what word best describes the skill set required to survive last year, it would be flexibility. As we continue to transition from grant based to fee-for-service based funding, being flexible is greatly important. As our clients, deliverables, available capacity, and partners become more diverse, we have been forced to adapt and deliver quality service that is fairly compensated. The more flexible we are, the better we are able to do this.

As highlighted in this document, there are many challenges that we have faced in the past year, from staff turnover to a substantial decline in previously consistent funding sources. In some cases, even new funding comes with challenges, such as how to complete new deliverables without sufficient funding for increasing capacity. This all brings us back to the key word, flexibility.

In the new context we are working in with our clients, it is no longer sufficient to simply provide a generic proposal with a dollar amount attached to it. Clients now increasingly require customized programming developed through consultation, often with a detailed cost structure. This concept has been working for us with our planting projects, and now we are starting to apply it to our extension programming.

With the arrival of requests for new deliverables, often taxing our existing capacity, we have been adapting. One recent, great example of how we have been flexible is our newest project, the Battle River Watershed Restoration Project. The funders required a more holistic approach to restoration, much more than simply planting trees, and for us to work in areas where we did not frequently operate. We would not have been able to do this project alone, and have partnered with the Battle River Watershed, Iron Creek Restoration Society, and Cows and Fish to provide technical expertise and a solid on the ground presence where we are unable.

I believe that with our capable staff, board, and partners we will rise to new challenges with capacity, new clients, and new deliverables. Indeed, I am actually quite excited about this opportunity. Lastly, I would like to thank everyone – professionals, volunteers, members and partners – for their support and contribution to the goals we work towards. All of you are invaluable to the development of our Society.

Thank-you for recognizing the **Potential** positive benefits this organization provides to Albertans and forming strong lasting **Partnerships** to deliver our programs and mend some damaged ecosystems. While we may never fully realize the dream of having all private landowners in Alberta recognize the full value (ecological and economic) of trees on their farms, if we maintain the 5 "P's" as highlighted above, we can still make a significant positive change.

**Call to Order** - Mikel Jackman - President Meeting called to order at 9:34 a.m.

#### Introduction

All present introduced themselves, with a brief description of affiliation and involvement with agroforestry/woodlots and AWES.

#### **Determination of Quorum**

11 members in good standing. Quorum requires 25% of members or 3 members (whichever is greater). 7 in attendance. Quorum was declared.

#### **Acceptance of Agenda**

#### Minutes 2014 AGM

Moved Byron, seconded Ken and carried that the minutes of the 2014 AGM be approved as circulated.

### **President's Report**

Mikel discussed brief highlights of 2014-15 President Report (page 4 of Annual Report). Tim expressed appreciation to AWES staff for good job on the fee for service work with AlPac.

#### Staff Report

Jeff presented 2014-2015 Project Manager Report (page 3 of Annual Report) and overview of AWES Staff Report Highlights 2014-2015 (page 14 of Annual Report).

## Financial Report

Ken provided brief overview of financial review (page 11 of 2014-15 Annual Report).

Unaudited financial statements to March 31, 2015 were circulated to members last week (attachment 1). No questions raised.

## **Auditor Report**

See Review Engagement Report, dated May 21, 2015 signed by Gil Dubrule, CMA.

Byron noted that 2014 AGM had appointed a new auditor. Mikel explained that she was unable to complete the engagement, so Gil (our previous auditor) agreed to take it on. Member acceptance of his review report will ratify Executive's decision to find an alternate auditor.

### 2015–16 Budget and Project Report

Jeff presented highlights of AWES organizational Budget 2015-2016 Overview (page 13 of 2014-2015 Annual Report).

- -Tim asked whether AlPac payment for fee for service should be recognized as 2015 revenue.
  - ➤ Jeff No, it was recognized as accounts receivable in 2014/15.
- -Gary asked whether there was a known sunset date known on GF grants or funding.
  - ➤ Jeff GF extension March 2016; riparian planting (don't receive money directly from GF landowners are still eligible); GF extension December 2017, AIP annual grant no guarantee from year to year (probably wouldn't succeed again unless pitch different service or project).
- -Ken so we need to continue to look for new programs/ projects and funding sources?
  - Jeff Yes, we need to continue to diversify funding as mentioned in President's Report.
- -Ken are there any new funding sources that support base administration costs?
  - Jeff not so much, always looking for new funding sources but for foreseeable future seems we'll need to rely on project surpluses for unrestricted funding to cover administrative expenses that cannot be allocated directly to a project expense.

## **Acceptance of Reports in Annual Report**

Two errors were noted for correction: 1) members list page 5 to exclude Weberville Community Forest Association and include ACA instead; and (2) correct footer June 12, 2015 in all cases.

Jill moved, Byron seconded and carried that the Annual Report (and each report therein) be accepted with revisions as noted above.

#### **Appoint Auditor**

Ken moved, Con seconded and carried that Gil Dubrule be appointed as our auditor for 2015-16.

#### Election - Members of the Board

Ken, Pieter and Roy are working on 2nd year of their Director term. Terms of all other Directors have expired.

Byron moved, Con seconded - Mikel Jackman for position of President - Mikel accepted. There being no other nominations Mikel was acclaimed.

Bylaws say other Directors are appointed at large and other executive positions are determined at the next Board meeting; however, Mikel noted that some Directors only agree to nomination on the basis that they not be appointed an executive position, so it was agreed to continue nominations of Directors and executive positions, concurrently.

Ken moved, Con seconded – Jill Henry for position of Vice-president – Jill accepted.

Jeff noted that Shonelle Wilkinson had been nominated and had indicated that she was willing to stand for Secretary.

Jill moved, Byron seconded - Gary for Director at large - Gary accepted.

FINANCIAL REPORT

As the Treasurer for AWES, I am pleased to submit the following Financial Report. I've reviewed the financial material as provided by staff, and all seems to be in order. Some highlights include:

- 1. AWES Unaudited Financial Statements for April 1, 2015 to March 31, 2016
  - a) Our review engagement report shows that our financial statements are sound, according to Gil Dubrule, CMA.
  - b) We had a small deficit for Fiscal Year 2014–2015 of \$528.45, down from a revenue of \$9,753 for Fiscal Year 2014–2015.
- 2. Comparative Income Statement for Fiscal Year 2015-2016 vs. Fiscal Year 2014-2015
  - a) Total revenue is up by \$31,323.71 year-over-year
  - b) Total expenses are down by \$41,605.56 year-over-year
- 3. Budget for Fiscal Year 2016-2017
  - a) Our projections are for a net deficit of \$4,941.22

As has been noted before by the AWES Board, it is important for AWES to continue searching out new sources of funding for the future. I am aware that staff have been actively involved in this, both on the grant-writing front and on opportunities that are not grant-based.

#### Planning and Policy Updates

• AWES staff and board members have reviewed existing policies and updated them to reflect current operations within the existing bi-laws.

#### **Project Activities**

- a. Growing Forward 2 Extension (September 2013 April 2016):
  - AWES staff organized, participated in, and presented at 64 events on topics including wood waste diversion, woodlot management, biomass fuel, fruit production, marketing ecosystem services, chainsaw safety, sawmilling, kiln usage, non-timber forest products, tree health, and shelterbelt design.
  - Spoke with over 5,843 people at workshops and tradeshows including landowners, university faculty, forest product suppliers, industry, county ag-fieldman, extension service providers from various research organizations, and NGO's.
- b. Riparian Planting Research Project (January 2014 December 2016): Project is funded through GF2, Counties, Industry and Federal Government to provide extension on riparian planting techniques and restore riparian areas.
  - Provided 21 workshops since the beginning of the project, 7 more to be completed by the end of the June 2016.

- Planted 20 demonstration sites across six counties with a total of approx. 51,677 seedlings and stem cuttings.
- Riparian planting manual first draft will be completed by July 2016.

#### c. Agricultural Initiatives Program (2015–2016):

Project is funded through lottery monies collected by the Provincial Government. This project aims to provide landowners and managers with information on importance of native pollinators and how to develop/improve their habitat as well as management of forest grazing systems.

- Provided 7 workshops on native pollinator habitat importance and improvement, and forest grazing to individuals including: county staff, NGO's, acreage owners, and farmers.
- AWES staff and contractors developed extension materials (i.e. reports, articles, and factsheets) on related subjects.
- Planting 1 demonstration site showcasing pollinator focused eco-buffers at CDC North office.

#### d. Tree Planting Projects:

AWES staff is currently involved in 10 planting projects where AWES is serving as a contractor, ranging from 500 seedlings to over 12,000. Client include the following:

- Edmonton Corn Maze
- Nature Conservancy of Canada
- Alberta Conservation Association
- Parkland County
- Forest Ontario/Forest Recovery Canada
- Battle River Watershed Alliance

#### e. Environmental Damages Fund - Restoration Project (June 2016 - July 2018)

- The goal of this project is provide landowners with information on improved pasture management (e.g. rotational grazing, fencing options, off-site watering systems) and restoration options (i.e. tree planting or allowing for natural restoration).
- Partnering with Cows and Fish, Iron Creek Watershed Restoration Society, and the Battle River Watershed Alliance.

#### f. Contract Extension Services

 AWES is having to charge for extension services more often with the loss of the GF2 funding. There have been both counties and other NGO's supporting our extension activities through direct funding. We have proposed the following 3 systems of direct cost recovery:

- i. Event or product related billing (e.g. charging per workshop)
- ii. Charging an annual retainer for a variety of services (e.g. workshops, consultations, article development).
- iii. Submission of extension program proposals upon development (e.g. native pollinator series or woodlot management planning courses)

#### Projects under Development

- ACA Development/Improvement of Wildlife Habitat; Application proposed providing 8 workshops in the Province. **Application was unsuccessful**.
- Fort McMurray Urban Reforestation AWES is currently working with the Arbor Day Foundation and Forest Ontario/Forest Recovery Canada to provide seedlings and larger stock to landowners in Fort McMurrary and to the City. Both organizations have a strong history of providing disaster recovery reforestation assistance, and are looking to provide AWES with funding in order to facilitate a multi-year extension and planting/tree distribution program. **Program development is on-going.**
- Shelterbelts and Crop Productivity Research AWES worked with GoA staff on a proposal to use geo-referenced producer collected crop yield data on field where a functional shelterbelt was located Crop yields would then be compared based on their distance from the shelterbelt to determine if any effect was created by the shelterbelt. Application was unsuccessful.
