AWES aids and partners with these groups with funding or by providing expertise on planting project design and implementation, tree health assessment, municipal policy guidance, restoration, agroforestry, bioengineering planning, sourcing plant material, and planting and maintenance of forested and transitional areas. Our planting projects extend across Alberta, and we promote community capacity building through extension services such as webinars, training and workshops. AWES is helping communities and landowners make the most of their forests, large and small.

Authority and Responsibility

The Board of Directors is the legal authority for AWES. As a member of the Board, the Director acts in a position of trust for the community and is responsible for the effective governance of the Society.

Requirements

Term

Directors are elected by the membership at the AGM. Directors serve for a two-year, consecutive term. Directors may be released at the end of the term, by resigning, or according to AWES bylaws.

General Duties

A Director is informed on Society's matters and participates in the Board's deliberations and decision in matters of policy, finance, programs, personnel and advocacy.

Director Responsibilities:

- Prepare for and actively take part in all Board meetings, including the AGM.
- Review and approve policies and recommendations put forward by the Board, its committees, or senior staff, when appropriate.
- Oversee the implementation and adherence to all Board policies.
- Evaluate the bylaws and policy manual and propose any necessary bylaw changes to the membership.
- Assess the Board's structure, approve changes, and assist with drafting required bylaw amendments.
- Take part in developing AWES's organizational plan and its annual review.
- Approve the annual AWES budget.
- Help identify, recruit, and mentor potential new Board members.
- Support fundraising efforts as they arise.
- Approve the hiring or release of the Executive Director, including their employment contract, based on recommendations from the Personnel Committee.

- Participate in evaluating the Executive Director's performance.
- Promote positive relationships among Board members, staff, committees, and the community to support AWES's mission.
- Follow the organization's bylaws, code of conduct, and relevant Board policies.
